This matter comes before the Court on multiple motions: 1) Plaintiff's request for an interlocutory injunction enjoining enforcement of Bryan County, Georgia's Interim Development Ordinance (the "IDO") and Bryan County, Georgia's Development Impact Fee Ordinance (the "DIFO"); and 2) Defendants' Motion to Dismiss.

Upon consideration of the pending motions, pleadings, evidence presented on May 10, 2019 and May 24, 2019, the credibility of the witnesses, arguments of counsel, the controlling law, and all other matters of record, the Court hereby **ORDERS** as follows:

Plaintiff's allegations in the complaint, as twice amended, taken as true, sufficiently state a claim. Accordingly, Defendants' Motion to Dismiss is **DENIED**.

Plaintiff failed to satisfy its burden to obtain an interlocutory injunction. Accordingly, Plaintiff's request for an interlocutory injunction is also **DENIED**.

The Court further ORDERS counsel for Plaintiff and Defendants to confer on an appropriate scheduling order in this case, including periods for discovery, amendment(s) to pleadings, dispositive motions, and trial. Upon counsel's agreement, a consent scheduling order shall be submitted to the Court for consideration.
